

Geographic, industry and currency exposures are carefully monitored, with limits placed on some individual markets and industries. When appropriate to a particular risk, currency hedges are made. The International Equity Fund seeks long-term growth of capital with no greater risk, but different performance characteristics, than a portfolio of high-quality U.S. securities. 50% of the fund is managed by Silchester International Investors, who seeks to buy financially strong companies at cheap valuations—focused primarily on the developed world. Artisan Partners manages 50% in a fund which invests in growth-oriented international companies selected from themes and industries that present accelerating growth prospects.
